

# 2016 Emerging Artists' Exhibition Application

## Qualifications

Artists ages 18-25 are eligible to submit 2-D and 3-D artwork for consideration in ArtHaus' Annual Emerging Artists' Exhibition juried art show. Open to residents and students within a 150 mile radius from Decorah in the Driftless region of northeast Iowa, southeast Minnesota, and southwest Wisconsin. All forms of media will be accepted including, but not limited to, painting, drawing, ceramic, fiber arts, jewelry, printmaking, and photography. Artwork must be original and have been completed within the last 2 years and adequately prepared for installation (*works not ready for installation will not be included in the exhibition*). Works may be for sale but this is not a requirement.

## Guidelines

Each applicant may submit images of up to 3 artworks, two images per work. Only digital images will be accepted in JPG or JPEG format at 300 dpi, minimum 1200 px on longest dimension. Files must be labeled with the artist's first and last name and entry number (*lastname\_firstname\_1.jpg, for example: picasso\_pablo\_1.jpg*). Video works will be considered and can be submitted MOV or MP4 format but applicant must be able to supply viewing technology.

Digital images along with all required application materials (*see below*) and a \$20 entry fee **must be received by midnight Friday, March 11, 2016**. Late entries will not be considered.

Artists will be **notified by Friday, March 18** as to the jurors decisions of which works will be included in the show. Selected works must be hand-delivered or shipped and **received by 5pm on Wednesday, March 30**. Shipping to and from ArtHaus is the responsibility of the artist.

There will be an opening reception open to the public on **Friday, April 1 from 6-8pm**. The exhibition runs **April 1 through May 13, 2016**. Works must remain on display for the entirety of the exhibition. Works listed for sale will be made available for purchase through ArtHaus, with 70% to the artist and 30% to ArtHaus should work(s) sell.

A Best of Show as chosen by the jurors will receive a \$200 cash prize and a solo exhibition during the 2016-2017 ArtHaus calendar year. A runner-up will receive a \$100 cash prize. Two additional Honorable Mention Awards will be named.

It is preferred that interested applicants complete an online application form, pay their entry fee via Paypal, and submit all required materials (*see checklist below*) via a Dropbox account (instructions available at [www.arthausdecorah.org/emerging-artists-exhibition/](http://www.arthausdecorah.org/emerging-artists-exhibition/)).
